PRODUCT DESCRIPTION:

Sliced cranberries are prepared from sound, mature berries of the commonly cultivated cranberry plant (Genus/species *Vaccinium macrocarpon*). The berries are sorted, cleaned, frozen, cut to the appropriate size, packed and returned to the freezer. The product is not processed to control for microbiological risks that may be found in unprocessed fruits.

The product is not adulterated or misbranded within the meaning of the Federal Food, Drug, and Cosmetic Act, including the Pesticide, Chemical, and Food Additive Amendments to this act. The processor shall obtain written statements from the growers that only registered pesticides were used and that no illegal or unsafe residues remain on the crops.
